Business Update

Completion of 5,000-ton anti-oxidant workshop and 10,000-ton integrated workshop for sulphenamides accelerators

Singapore – 10 July 2008, the Directors of China Sunsine Chemical Holdings Limited (“**China Sunsine Chemical**” or “**The Group**” or “**尚舜化工**”), a leading producer of rubber chemicals and one of the world’s largest rubber accelerator producers, refer to the Group’s results announcement dated 9 May 2008, and would like to provide an update on the progress of its 5,000-ton anti-oxidant workshop and 10,000-ton integrated workshop for sulphenamides accelerators.

We are pleased to report that our 5,000-ton anti-oxidant workshop has been completed according to schedule, and is currently into trial production. Further, the Group is on track to expand this anti-oxidant workshop to a capacity of 10,000 tons by the end of FY2008.

In addition, we are pleased to report that our 10,000-ton integrated workshop for sulphenamides accelerators has also been completed, and is into trial production mode. This workshop allows switching of production of different sulphenamides accelerators CBS, TBBS and DCBS within a short period of time, enabling the Group to better meet the demand of customers.

Barring any unforeseen circumstances, the Directors are optimistic of the Group’s aim of achieving a year-end production capacity of 50,000 tons for rubber accelerators and an effective capacity of approximately 44,000 tons for the year.
